The following rules and regulations apply to this contest:

- 1) All entries for the contest are to be submitted to Sherry Hunt, prior to September 15, 2016. Please email to bryanandhunt@sympatico.ca**
- 2) Registration forms are available from Sherry Hunt at the above email address or on the Brampton Fair Web Site www.bramptonfair.com or for pick up at the Brampton Fair Grounds, 12942 Heart Lake Road, Caledon. 905-843-0210 (office open Wednesdays)**
- 3) All contestants must be under the age of 14 years on the date of the contest**
- 4) The Huttonville Lions Club is the sponsor for this contest, and the judges reserve the right to make the final decisions on all matters regarding the contest. All decisions of the judges are final. Judges will not enter into discussion with parents or guardians.**
- 5) Each act must provide its own music. A sound system will be provided with equipment to play background music.**
- 6) The acts must be safe, and any act involving risk of performer's injury is strictly prohibited.**
- 7) The contest is open to amateurs only. An Amateur is a person who performs as a part time (hobby) rather than a profession.**
- 8) The winners are selected by a panel of judges. All contestants must meet the requirements set by the Region of Peel Agricultural Society and Sponsors. Judging will be based on audience appeal, natural ability, stage presence, and the quality of the performance.**
- 9) The contest will be held on the outdoor stage at the Brampton Fall Fair. In the event of bad weather, the contest will be moved indoors to the multipurpose building.**
- 10) There is no entry fee to enter this contest, however all competitors and their supporters will be charged admission to the fair. The Brampton Fair admission fees are as follows: Adults \$10.00 Children 5 - 12 years \$5.00 and children 4 and under free. Parking is free.**
- 11) Each contestant and parent/guardian will be asked to sign a consent form and agrees to these terms and will be present at 9:30 a.m. on September 18th. Latecomers will not be permitted to perform.**
